TERMS AND CONDITIONS

Unless otherwise agreed in written agreement executed by an authorized officer of DISCO, the "TERMS AND CONDITIONS" of this quotation supersedes and cancels all prior discussions, agreements and understandings relating to the Products defined in below.

Customer will be deemed to accept this "TERMS AND CONDITIONS" upon its issuance of the purchase order or any other agreements regardless of written, oral or implied for the Products corresponding to this quotation (collectively "PO"). Any terms or conditions in the PO other than this "TERMS AND CONDITIONS" shall not become effective except agreed in written agreement executed by an authorized officer of DISCO.

Article 1 (Sales and Orders)

DISCO CORPORATION (including its affiliates more than 50% of which entities are controlled by DISCO, collectively "DISCO") will propose customers ("Customer") to sell, provide services (including but not limited to installation and maintenance of Products, hereinafter "Service") and lease etc the products ("Products"), of which contractee is Customer and contractor is DISCO (collectively "Transaction") according to and based on the terms and conditions of this quotation ("Quotation") and this Terms and Conditions.

This Terms and Conditions shall be applied to Customer's acceptance corresponding to this proposal by DISCO and it shall not be changed, amended or waived, in any way whatsoever (including, but not limited to, the terms and conditions stated in Article 2 (Warranty) by Customer afterward), except by written agreement executed by an authorized officer of each party.

In the case that the Products broke down because of DISCO's fault even though Customer uses the Products in normal/proper environment, condition, or methods, DISCO will repair it free of charge under and subject to the Products being under its warranty ("Warranty"). The contents and term of Warranty shall be according to those DISCO decides in each Products. If Customer and DISCO agree with different terms and conditions relating to the Warranty, such different terms and conditions will be applied.

DISCO defines seven (7) years (eighty four (84) months) from shipment of the Products (only machines) as the warranty period for supply of spare parts. However, this period may be shortened for some parts (some laser oscillators and some SD engines). Note that even if the supply period for the applicable part has been exceeded,

Article 10 (Customer) apply the part as long as circumstances permit.

DISCO will provide compensation for damages ("Damages") in accordance with the "Terms of Responsibility" in below in case that the Products and/or Service causes any damages, defectiveness, or destruction ("Defects") to Customer's products or products in progress, etc., regardless of whether or not the Products are under Warranty.

However, Damages will not include loss of opportunity, loss of profit, damages caused by exceptional circumstances, incidental damages, consequential damages, etc., and DISCO will not be liable for the compensation of them under any circumstances.

In addition, DISCO will only be liable for the compensation under and subject to the Defects objectively being proved that they were due to the reasons attributable to DISCO (initial failure, improper design, unachieved specification, obvious defects, or obvious violation to customer's instruction, etc.).

DISCO will compensate the amount which DISCO's liability ratio for Defects is multiplied to actual Damages of the devices in the defective wafers up to, whichever lower, the total amount of the price of first twenty five (25) pieces of wafers or the total amount of the price of the wafers in the first cassette processed on or after the occurrence of the Defects in the Customer products or products in progress, etc.

However, under any circumstances, the amount of the compensation for the Damages shall not exceed ten (10) % of the sales price of the Products (except for precision processing tools) which caused the Defects. For avoidance of doubt, in the case that the Products caused the Defects are the blades, wheels and in the case of the Service, the terms of "ten (10) %" aforementioned shall not be applied and the amount of the compensation for the Damages shall not exceed the purchase price of ten (10) wheels, two-hundred (200) blades and purchase price of the Service which caused the Defects. In addition, DISCO will only be liable for the compensation under and subject to the following terms:

- (1) Not using the Products in erroneous environment, condition, or methods;
- (2) Products were not transported or moved by Customer itself after those installation or start-up by DISCO;
- (3) Customer using the precision diamond tools (eg; blades, wheels) manufactured and sold by DISCO;
- (4) Customer not using the parts other than genuine DISCO brand, which were manufactured by or purchased from any other parties than DISCO;
- (5) Seven (7) years have not passed from the shipment of the defective Products or thirty (30) days have not passed from the provision of Service;
- (6) Defective Products have not been repaired or modified (excluding the repair or modification by DISCO or that with written consent of DISCO);
- (7) Products have never been maintained by any other parties than DISCO, and the Defects are arisen despite of Customer making the proper maintenance for the Products according to the manuals provided by DISCO and such fact is proved by objectively recorded evidence;
- (8) Defects are not caused by Customer's failure in replacement of lifetime parts and consumables due to exhaustion, abrasion, deterioration etc;
- (9) Defects are caused even though customer checked condition of the Products properly (including but not limited to checking Products run or operate normally or Products run or operate as Customer expected) after the Service, and Customer promptly notified DISCO of such Defects;
- (10) Defects are not caused by Customer's processing methods/conditions and usage of Products without written consent of DISCO;
- (11) Customer not continuing the use of the defective Products despite realizing the Defects.

Article 4 (Intellectual Property Rights) CHMQ2310241039-01

(12) Customer's process is objectively confirmed as appropriate from the point of prevention or discovery of the Defects and DISCO will give no guarantee of no infringement of any third party's intellectual property rights. Even though Customer is claimed by any third party that Products and/or Service infringe its intellectual property right (including without limitation patent) rights and/or processes, DISCO shall indemnify and hold Customer harmless and DISCO shall not be liable for the loss and will also have no other responsibilities for the infringement.

Article 5 (Limitation of Liability)

Except for those clearly stipulated in this Terms and Conditions, DISCO's liabilities in each and every instance under the Transaction of the Products and/or Service shall be limited up to the total amount paid by Customer to DISCO for the Products and/or Service specified in this Quotation. Even though there are several causes in the damages to the specific Products of Customer or Service for Customer, such limitation shall not be increased.

Article 6 (Non-application)

This Quotation and the Transaction between the parties shall not be governed by the United Nations Convention on Contracts for International Sale of Goods, the application of which is expressly excluded.

Article 7 (Entire Agreement)

This Terms and Conditions evidences the entire agreement of the parties and supersedes and cancels all prior discussions, agreements and understandings with respect to the subject matter hereof between the parties, written, oral or implied. Any modification or changes shall not become effective except by written agreement executed by an authorized officer of DISCO.

Article 8 (Condition for Equipment)

- (1) Test cut is needed before equipment shipment to be considered as buy off criteria.
- (2) Installation and initial training at Customer's facility will be provided at no charge.
- (3) Customer's internal buy off should be finished no longer than 1 month after equipment's arrival at facility which is under the condition that there is no any problem related to equipment itself.
- (4) The ownership of equipment shall not belong to Customer until Customer releases all the outstanding payment to DISCO.

Article 9 (Cancellation Charge and Overdue Payment Charge)

"Cancellation Charge" will be charged in the case where Customer cancels the purchase order as follows:

10% of the purchase price- 55 days and more before confirmed delivery date

25% of the purchase price- 25-54 days before confirmed delivery date

50% of the purchase price- 01-24 days before confirmed delivery date

"Overdue Payment Charge" will be charged as penalty in the case where Customer fails to pay the purchase price to DISCO upon the payment due date as follows:

At the rate of 0.05% of the overdue amount per day until fulfil the payment of overdue amount.
